Students will understand the fundamentals of power system electromagnetic transients theory and applications, for both analytical methods and numerical methods, and improve their independent thinking, literature review skills, research programming skills, and oral and written communication skills at the graduate level.

Although Mandatory Reporters must file a report, in most instances, a person who is subjected to the alleged conduct will be able to control how the report is handled, including whether or not to pursue a formal investigation.
